## National Security Law (NSL) & Canada's Extradition treaty with Hong Kong

- June 30 Submitted NSL issues brief to all Ministers. MPs and staffers
- June 30 <u>Joint Statement with 19 groups on National Security Law</u> and called on the Canadian Government to revoke Hong Kong's special administrative status and end Canada's extradition treaty
- **June 30** Launched an email campaign to Ministers & MPs highlighting Canada's extradition treaty with Hong Kong, and to denounce this horrendous law (Hong Kong's NSL) that breaches the Sino-British Joint Declaration and seeks to impose jurisdiction on international communities (15k reach)
- July 2 Met with senior advisors from the Prime Minister's Office to discuss Canada's extradition treaty with Hong Kong, as well as the implications of the National Security Law for Canada and Canadians in Hong Kong
- July 3 Applauded that Canada banned sensitive military exports to Hong Kong and suspended the Canada-Hong Kong extradition treaty, meeting one of ACHK's five demands & campaign goals

## OUR WORK Foreign influence operations

- January 19 January 25 Hosted events along with Vancouver community groups: Our Voices
  Under Oppression. Human Rights & Authoritarian States; International Human Rights: What's At
  Stake & Why HK Matters: Democracies Under Threat: Foreign Policies, Trade Wars & Tech; Digital
  Democracy, Misinformation, And Propaganda
- June 9 Launched issues brief on academic influence and shared with MPs
- June 14 Launched issues brief on political influence and shared with MPs
- July 28 ACHK launched campaign to condemn Tong Xiaoling, the Chinese Consul General in Vancouver, who attempted to coerce Chinese Canadians to comply with the CCP
- August 11 Testified before the Special Committee on Canada China Relations on the issue
- August 17 Launched a <u>detailed report on National Security and Chinese State Influence During Aug 16-19, 2019</u> to outline nuances on how Beijing mobilizes Chinese communities abroad to exert influence on Canadian politics, businesses, and institutions
- Launched education campaign on elite capture and the 123 Canadians detained in China
- October 1 October 24 Helped launched #NoBCforXi demanding candidates in BC's provincial election take a stand against CCP's human rights violations and foreign infiltration in Canada
- October Collaborated with local Toronto groups on a <a href="by-election candidates">by-election candidates</a> survey & campaign
- October December Arranged meetings between ACHK's experts (on national security and foreign influence operations) and MPs and staffers

## OUR WORK Resettlement and asylum policies for HongKongers

- April June Consulted with Hong Kong support groups in Canada and Hong Kong on what Hong Kongers are facing and what resettlement policies will best tackle situations-at-hand
- **June 17 December -** Met regularly with senior officials of Global Affairs about immigration and refugee options and the challenges Hong Kongers face
- **June 24** Met with the Parliamentary Secretary of Foreign Affairs and senior officials from Global Affairs about the National Security Law, and immigration and refugee needs of Hong Kongers who now face persecution
- June 26 July 7 Submitted a detailed policy brief on immigration and resettlement to senior officials of Immigration, Refugees and Citizenship Canada, Global Affairs departments, senior advisors of the Prime Minister's Office & Deputy Prime Minister's Office and every MP & Senator
- July 2 Met with senior advisors from the Prime Minister's Office to discuss ACHK's resettlement policy brief
- **July December -** Bi-monthly meetings with the Immigration department's policy director to discuss relevant policy recommendations from ACHK and other Hong Konger groups
- August 31 ACHK members presented <u>Lennon walls at Cabinet Ministers' offices</u>, demanding the government immediately implement safe haven measures for Hong Kongers
- November 16 Testified before the Standing Committee of Citizenship and Immigration regarding the pandemic's impact on international students from Hong Kong

## OUR WORK Sanctions and trade diversification

- **January 23** Hosted events alongside Vancouver community groups on topics related to "Democracies Under Threat: Foreign Policies, Trade Wars & Tech"
- April 15 December Launched 8 campaigns (reaching over 57,000 people) to increase awareness on the situation in Hong Kong and to call for sanctions, which connected us to over 100 politicians
- **July 3 8 -** Submitted a sanction list to MPs, PMO, DPMO, and the Foreign Affairs Minister, and conversed with respective offices on the need to invoke sanctions against officials committing human rights atrocities and eradicating Hong Kong's autonomy
- **July 7** Launched email campaign to call for support to reconvene the Subcommittee on International Human Rights (SDIR) which is critical to advancing Magnitsky sanctions & measures for human right violations in occupied East Turkestan, Tibet and Hong Kong
- July 10 Released ACHK's sanction list to the public
- July 14 Launched <u>a joint letter with over 100 signatories calling for sanctions</u>, with MPs from every major political party in Canada, and with solidarity from Uyghur, Tibetian, Chinese, and Hong Konger community groups in Canada
- August 11 Called for sanctions in testimony before the Special Committee on Canada-China Relations
- August December Regular meetings advocating for sanctions & trade diversification with PMO, Global Affairs, Foreign Affairs (FA) Minister's office, NDP's FA critic, CPC's Shadow Minister on FA

## THE CANADIAN FIVE DEMANDS AND HOW IT WAS DETERMINED

# Community Consultation Survey of 13,000+ HongKongers

**In January,** we launched a community consultation survey together with Citizens' Press Conference. Over 13,000 participants from Canada and Hong Kong responded with these demands for Canadian leaders.

- 1. Hold Hong Kong and Chinese officials accountable for human rights atrocities, police brutality, and erosion of Hong Kong's autonomy, by invoking the Justice for the Victims of Corrupt Foreign Officials Act (Sergei Magnitsky Law)
- 2. Provide humanitarian support to Hong Kongers, Tibetans, Uyghurs, Chinese, and other groups seeking asylum from the Chinese Communist Party;
- 3. Safeguard Canadians' fundamental freedoms from erosion by proactively combating the Chinese Communist Party's interference in Canadian society;
- 4. Investigate and combat foreign interference and influence in Canadian institutions
- 5. End all exports of military/police goods and technology to China that are used for human rights violations by the Chinese Communist Party
